

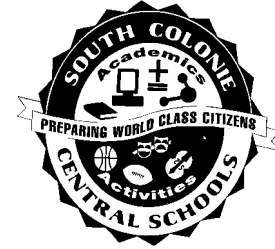

2. PLEDGE TO THE FLAG

Board President, Mr. Kiehle led the pledge to the flag.

3. PRESIDENT'S SPOTLIGHT**Eagle Scout Recognition – Kevin Ritz**

Kevin started his scouting experience by joining Troop 1077 in 2010. Kevin worked diligently earning the ranks of Tenderfoot, Second-Class, First-Class and Star Scout by February 11, 2014. He earned the rank of Life Scout on October 6, 2015. Kevin served in several positions of leadership including Assistant Patrol Leader, Patrol Leader, Quarter Master and Librarian. Kevin also received the Veteran Scout Association 100+ Hour Service Award and the VFW Post 8692 Scout of the Year for 2017. On January 26, 2017, Kevin earned the rank of Eagle Scout and was honored at the Eagle Scout Court of Honor on May 20, 2017.

Kevin's Eagle Scout project took place at The Church of St. Clare. His project encompassed planning, project development, management, and leadership. He met with the Building & Grounds Committee to come up with a plan to solve a landscape erosion problem at the Central Avenue church entrance. He priced out the cost of supplies and how long the project would take. He fully fund the project by outside donations and recruited volunteers. He led a team of 11

volunteers that removed dead shrubs along with a tree stump, brought down a section of property containing eight or more inches of mulch/dirt to two inches below the sidewalk, relocated the mulch/dirt, removed rotting landscape timbers, installed two yards of new river rocks to correct the erosion from roof run off, installed new landscape timbers not only to replace the 12 foot section that was rotted, but an additional 30 feet of timber was installed to box in the newly installed river rocks.

10. RESOLUTION – AUTHORIZATION FOR SOLE SOURCE PROCUREMENT

WHEREAS, the District has adopted, reviewed and evaluated instructional resources for Reading and recommended the Fountas & Pinnell PM Readers for Grade K through Grade 3 to the Board of Education as the product that will best meet the pedagogical needs of the District; and

WHEREAS, the acquisition of the Fountas & Pinnell PM Readers Textbooks and Curriculum Materials is desired for use in Grade K through Grade 3 instruction; and

WHEREAS, no other instructional materials provide substantially equivalent or similar benefits to that provided by the Fountas & Pinnell PM Readers; and

WHEREAS, after reviewing the benefits received from the Fountas & Pinnell PM Readers, the cost of said instructional materials is reasonable in comparison to other instruction and evaluation materials in the marketplace for Reading; and

WHEREAS, in accordance with Section 103 of the General Municipal Law, the governing board may approve such sole source procurement without competitive bidding when the possibility of competition does not exist for the product or service; and

WHEREAS, the South Colonie Central School District desires to procure the Fountas and Pinnell PM Readers for Grade K through Grade 3 instruction based on the attached proposal from Heinemann, which is the sole source vendor for this product, for an initial investment of \$63,229.79 to be funded from the 2016-2017 General Fund Budget.

NOW, THEREFORE BE IT RESOLVED:


