WHEREAS, South Colonie Central School District is desirous of acquiring a certain parcel of real property consisting of 5,031 square feet located in the Village of Colonie, County of Albany, and State of New York, which is owned by Goldstein Realty Holdings, LLC; and

WHEREAS, Goldstein Realty Holdings, LLC, is the record owner of the certain parcel of real property consisting of 5,031 square feet located in the Village of Colonie, County of Albany, and State of New York, more particularly described in the Warranty Deed with Lien Covenant attached hereto as Exhibit "A"; and,

WHEREAS, Goldstein Realty Holdings, LLC has offered to convey that certain parcel of real property consisting of 5,031 square feet located in the Village of Colonie, County of Albany and State of New York, to the South Colonie Central School District by Warranty Deed with Lien Covenant; and,

WHEREAS, Goldstein Realty Holdings, LLC desires a 2,536 square foot easement for utilities and emergency access which easement is located on real property owned by the South Colonie Central School District and is located contiguous to the real property owned by Goldstein Realty Holdings, LLC; and

WHEREAS, the South Colonie Central School District is desirous of granting the 2,536 square foot easement for utilities and emergency access to Goldstein Realty Holdings, LLC, as more particularly described in the easement attached hereto as Exhibit "B"; and

WHEREAS, the school district will not lose any parking spaces at the Transportation Department's parking lot by virtue of the grant of this easement; and

WHEREAS, Goldstein Realty Holdings, LLC shall stripe the real property demarcating the easement; and

WHEREAS, Goldstein Realty Holdings, LLC shall demarcate the relocation of the parking spaces arising by virtue of the grant of the easement.

NOW, THEREFORE, BE IT RESOLVED:

That the Board of Education of the South Colonie Central School District hereby authorizes the acquisition of the certain parcel of real property consisting of 5,031 square feet located in the Village of Colonie, County of Albany, and State of New York, which is owned by Goldstein Realty Holdings, LLC, more particularly described in the attached Warranty Deed with Lien Covenant; and

That the Board of Education of the South Colonie Central School District hereby authorizes and grants the 2,536 square foot easement for utilities and emergency access located on real property owned by the South Colonie Central School District and located contiguous to the real property owned by Goldstein Realty Holdings, LLC and more particularly described in the attached easement; and

- 3. That Goldstein Realty Holdings, LLC shall stripe the real property demarcating the easement for utilities and emergency access and shall further demarcate the relocation of the parking spaces lost by virtue of the grant of the easement; and
- 4. That the President of the Board of Education of the South Colonie Central School District is hereby authorized to execute any and all documents associated with the acquisition of the certain parcel of real property and the granting of the said easement, each respectively described herein.


